<u>Change in CPO-</u>Mr. Taylor will no longer be CPO this year. It will now be JT Lane. JT is certified. He can take care of the grass too in lieu of membership dues.

Mr. Lane is draining the pool, pressure washing and cleaning, and assessing paint job.

Dues: Dues will remain the same this year!

<u>**Guest Passes-</u>**Each family is receiving 4 guest passes to use for in-town guests. "In-town" means within the 10 mile radius. Each pass is used one time, one pass per person. Passes must be turned in to the lifeguard along with the \$5.00 guest fee. How can we get the passes to people. This is experimental this year in the hopes of bringing in new members.</u>

Opening Weekend Celebration:

On Monday, May 25, we will have have an Opening Day Celebration. The pool will open on Saturday, May 23, however we feel more folks will be in town that Monday evening. The pool board is sponsoring an ice cream sundae party and we will let your child leave their stamp on

Swim Lessons:
